CODE ENFORCEMENT OFFICER / BUREAU OF FIRE SERVICES - (Reports on file) Stated working on mobile home review and house at 990 Hudson Ave is legally reoccupied.

MOTION to authorize the mayor to enter into a contract with Colonial Road Apts. for sewer connection fees, on a reserve basis with a linear prorated refund basis to end at 50% refund, within a two-year time frame made by Trustee Nelson, seconded by Trustee DeMarco Motion carried 4-0

ENGINEERING – (Report on file)

MAYOR UPDATE: Received three estimates for the concrete at 682 Hudson, the new pocket park, the lowest being from RL Rathbun, LLC

MOTION to accept RL Rathbun, LLC estimate for \$5,688 for the concrete work at 682 Hudson Ave made by Trustee Nelson, seconded by Trustee DeMarco Motion carried 4-0

Mayor stated she needs more reliable contractor names provided for estimates for the new village hall renovations.

The Board discussed holding one or two open nights at the old library to try to sell items left in the building, more information to follow.

MOTION to pay Witchcraft Body and Paint for the repairs to Joseph Woods truck made by Trustee Doyle, seconded by Trustee DeMarco Motion carried 4-1-0

Mayor Wood Zeno discussed bringing back the "Golden Cane" award to the oldest living member of the Village.

Roth ID tag information sheets will be ordered to hand out on Family Day. Clerk Tedesco found this program to tag car seats with information for emergency situations, more information to follow.

TRUSTEE UPDATES:

Trustee DeMarco requested a new sign for the south end of the Village, and we will put the older sign at the north end of the village.

MOTION to purchase a new sign, at a size three feet larger than the existing sign, for the south end of the village to say "Welcome to Stillwater, A Village of Champions" made by Mayor Wood Zeno, seconded by trustee Nelson Motion carried 4-0
