2-The Park Avenue Bridge- a recommendation was made to place a 10,000-pound weight limit. Attorney Peluso will further investigate.

SPECIAL GUEST- Drew Aliberti from Flatley Reed, Inc. addressed the Board regarding their "Wish List" for projects that may have grant availability. Mayor Wood-Zeno listed several projects, including the Firehouse renovations, the Park Avenue bridge, sidewalks and a protected bike path.

The Board agreed that the Firehouse project should take priority, and the next step would be to obtain a survey of the Firehouse property.

Mayor Wood Zeno stated she would like to proceed with ordering the Bike Repair kit for Revolution Park.

Mayor Wood Zeno stated that she would like to purchase a Portable Voice Amplification System to be utilized at Board meetings and other Village events. Trustee Nelson expressed interest in this purchase and will research.

Mayor Wood-Zeno reported that she emailed Rob McCoy, president of the Stillwater Central School District Board of Education regarding sharing the cost of the new Welcome Sign at the south end of the Village which would list all State Champions from the District for the past decade. Mr. McCoy will discuss this with the Board of Education members and report back to Mayor Wood-Zeno.

Mayor Wood-Zeno introduced the idea of reaching out to Village residents and others for historical pictures, books, mementos, etc. of the Village to display in Village Hall on the empty bookshelves.

Mayor Wood-Zeno discussed the idea of the Christmas Village next December which would coincide with the Tree Lighting and Blockhouse Park Memorial trees. The Experience Stillwater committee is willing to assist with this event. Next step is for Mayor Wood-Zeno to reach out to all businesses.
